


### Pre-payment plans

### How to arrange your plan

In the first instance, please contact us for our full-colour brochure which includes all prices and full details of the plans offered for cremation. Prices need to be calculated for burial on an individual basis.

#### Guaranteed plans - no extra to charge for

The plan is guaranteed to cover the funeral director's costs specified in the Purchase Agreement. Any money you have paid towards the cost of payments to third parties such as crematorium fees, clergy, churches or doctors etc will rise in line with the Retail Price Index (RPI). If the cost of these payments increase at a rate in excess of RPI, then your next of kin/executor will be required to pay any shortfall.
